FOR VALUABLE CONSIDERATION AND TO INDUCE PERMISSION TO PARTICIPATE IN EQUESTRIAN ACTIVITIES HELD AT MURIETA EQUESTRIAN CENTER (MEC), 7200 ONE PINE DRIVE, RANCHO MURIETA, CA 95683, EACH OF THE UNDERSIGNED AGREES TO THE FOLLOWING TERMS AND MAKES THE FOLLOWING WARRANTIES:

I ACKNOWLEDGE THAT PARTICIPATING IN EQUESTRIAN ACTIVITIES, WHETHER AS A SHOW PARTICIPANT OR AN AUDIENCE MEMBER, IS A HAZARDOUS RECREATION ACTIVITY WITH RISK OF DAMAGE OR PERSONAL INJURY, INCLUDING PARALYSIS OR DEATH, TO ANY PERSON OR PROPERTY. EQUINES HAVE THE PROPENSITY TO BEHAVE IN WAYS THAT MAY RESULT IN INJURY, HARM, OR DEATH TO PERSONS ON OR AROUND THE EQUINE HAVE UNPREDICTABLE REACTIONS TO SUCH THINGS AS SOUNDS, SUDDEN MOVEMENT, AND UNFAMILIAR OBJECTS, PERSONS, OR OTHER ANIMALS ARE SUSCEPTIBLE TO CERTAIN HAZARDS SUCH AS SURFACE OR SUBSURFACE CONDITIONS, COLLISIONS WITH OTHER EQUINES OR OBJECTS PROPENSITIES INCLUDE KICKING, BITING, STAMPING, STUMBLING, REARING, AND OTHERS TACK EQUIPMENT CAN FAIL RESULTING IN FALLING OR LOSS OF CONTROL AND ACTIVITIES HAVE THE POTENTIAL OF THE PARTICIPANT(S) TO ACT IN A NEGLIGENT MANNER THAT MAY CONTRIBUTE TO INJURY TO THE PARTICIPANT OR OTHERS, SUCH AS FAILING TO MAINTAIN CONTROL OVER THE EQUINE OR NOT ACTING WITHIN THE PARTICIPANT'S ABILITY.
